WHISPER CREEK HOME OWNER ASSOCIATION ANNUAL MEETING MINUTES

Date | time 1/28/2020 6:00 PM | Meeting called to order by Marc Smith

In Attendance

Sign in sheet and list of proxies are attached as enclosure (1). All four board members were in attendance. Marc Smith noted there were insufficient proxies and residents present for a quorum. Whisper Creek has 221 residents and 62 undeveloped builder lots, 59 attendees including 5 proxies. We needed 94 combined residents and proxies to meet the quorum requirements, and a total of 184 to make any changes to our CC&Rs, according to our Florida statutes. Therefore this meeting would continue as a regular Board Meeting, and the Annual Home Owners meeting would have to be rescheduled.

Review of Previous Minutes

It was stated that the board electronically review and approve meeting minutes shortly after each meeting. Kevin Maxwell proposed motion to approve HOA Board Meeting minutes from 9 Sep 2019, Paige Warren 2nd the motion and the board unanimously voted to approve the minutes.

Whisper Creek HOA – Our Year in Review (Accomplishments/Challenges)

Every year since inception, the HOA has ended the year in debt, and most years couldn't pay the Electrical/Management Co./Lawn Care bills past July or August thru the remainder of the year.

2019 began with \$13,881 in arears and ended with \$924.38 in the bank, however we did have three accounts we were unable to pay in December, Lawn Care (\$573); Gulf Power (\$1369.99); and Etheridge for Nov & Dec (\$1600)

Re-competed the Lawn Care contract and moved from Green Day @ \$928 p/month (\$11,136 p/year) to Emerald Coast Lawn Care, @ \$573 p/month (\$6,875 p/year) and saved \$355 p/month beginning April 2019 saving \$3,195 for the year, will save \$4,261 in future full years.

Marc Smith begin overseeing the installation of street light with the hope of saving new charges of \$27 per month per new light being installed. Beginning 2020 the board will begin reviewing the installation of new street lights, based on safety and fiscal responsibility for future lights.

To save money the board voted to not utilize Etheridge maintenance for future general repairs/maintenance. The charge of \$44 per hour seemed excessive and the plan was to research new companies to utilize, but with the budget situation no new company was ever contracted.

Budget

Joey Milstead provided budget status, as of 31 December 2019. YTD revenue \$46,613.00 with a carry in of \$2,035.04; total operating budget of \$48,648.40; expenses \$47,723.55, checking account ending balance is \$924.38. We collected \$5,862.81 more than the original budget plan due to the increase of sold homes. All home owners have been notified of the increase in annual assessment to \$250.00. This increase was voted and approved at the Sep 2019 board meeting. But the goal for future years, as the HOA becomes fiscally sound, is to reduce the annual assessments. As of the time of the meeting, 8 residents had outstanding HOA fees, totaling \$2,242.72 and 8 builders, totaling \$400, have not paid 2019 assessments the total outstanding assessment balance is \$2,642.72. The 2020 budget was presented and is provided as enclosure (2), revenue generating from residents should be \$51,000 builder

assessment will be \$3,950 for a total revenue of \$54,950. Expenses for 2020 are projected at \$46,393.99, providing a reserve balance of \$8,556.01. The revenue and reserve balance could increase as builders sell and close more homes.

Property Management Updates

Etheridge Property Management Company did not send a representative to our meeting

Home Owner Discussions

- Marc Smith began the meeting with a welcome and the discussion about meeting quorum requirements (see attendance section).
- Since this meeting will not serve as the Annual Homeowners meeting, another meeting will be held, homeowners suggested including on the agenda, how important this meeting is. Also discussed is how expensive it is to have another meeting, and if we don't have a quorum again, another meeting, etc.
- Another addition requested to the agenda will be to highlight the areas of the CC&Rs that will be addressed at the next meeting, and include the cost of the meetings, \$ 50 or more for room; Etheridge provided at the last meeting the projected cost of postage and mailings for annual meeting is \$230.00. During the meeting a homeowner informed the board Annual Meeting Packages could be hand delivered, will need to research additional information to see how this could save the HOA money.
- It was mentioned by several homeowners; Etheridge is in violation of their contract by not sending a representative. Joey Milstead had been aware Joslin Ellis would not attend, but had not been informed of whether or not a replacement would attend.
- A question regarding the minutes was asked, and the minutes will be published to the Etheridge web site and both Whisper Creek Face Book pages as soon as the secretary has them completed and they are reviewed and approved by the entire board.
- It was asked if the board could relay our current HOA assessments to the remaining builders in our area, Joey Milstead met with Holiday representative on 1/29/20 looking for proxy forms, and let them know our current assessment amount, we will also send them something in writing. DR Horton has sold their model home, and no longer on site.
- Kevin Maxwell provided some ACB information, but didn't have the total number of requests process, but it was "a lot". Board was made aware that ACB requests have not always been sent for approval. Fences, buildings erected, etc., have been completed without approval. It was stated most would have been approved if they had been submitted. The board proposes the following to be voted on if a quorum is reached at the next meeting:
 - 1. Give amnesty to all improvements from 1/28/20 back, not need to submit ACB request
 - 2. Request everyone that made improvements, and didn't submit a request, submit a request seeking approval, if the project is disapproved, the home owner must undo the project.
- In the future, if a homeowner doesn't submit a request to the ACB they would be subject to fines or fees, that will be discussed/addressed by the new Statutory Committee.
- Covenants, Conditions and Restrictions (CC&Rs) changes were brought up, since it takes 2/3 attendance of homeowners to vote on changes in the CC&Rs, nothing could be voted on tonight, it was suggested that possible changes be added to the agenda for the next meeting
- Home Owners have been very vocal of their dis-satisfaction with the performance of Etheridge Property Management, the Board agreed at the last meeting to research possible replacements. The current Board felt that decision needed to be made by the new incoming board as to which company would be selected. Since a new board could not be selected, the current board President, Marc Smith made a motion to terminate our contract with Etheridge Property Management and send them a letter stating the termination would be effective in the required 60 days, Joey Milstead 2nd the motion, the board voted unanimously to terminate contract with Etheridge Property Management.

- A home homeowner suggested the board reduce the number of companies to review, but the board agrees 3
 Full service companies and 2 Accounting service companies is sufficient, and will use the proposals to make
 the decision as to which company we will move forward.
- In prior meetings the lack of fines/fees to enforce CC&R violations was discussed. Board was informed a Statutory Committee was required to assess fines. Marc Smith suggested residents send the board an email if they would like to be on this committee, however committee members cannot be spouses or related to any board member. Fees would be assessed at a future determined rate for repeated or continuous CC&R violations

Open Forum

- A homeowner wanted to know what a Management Company does for an HOA, the list includes: Maintain web based portal for homeowner to access documents pertaining to Community; provide online payment options for annual assessments; provide online Architectural Control Board forms and submission; collection of annual assessment and general accounting services (receiving and paying monthly obligations); driving through and assessing CC&R compliance, sending letters for non-compliance and answering community questions relating to CC&Rs; hiring and working with attorney to collect delinquent annual assessments; researching for board and establishing contracts for services such as lawn care and liability insurance; sending letters and notification of annual meetings as well as collecting proxy information; attending board and homeowner meetings as per contract.
- Marc Smith indicated any homeowner could inform board or management company of short term
 conditions that would be in normal violation of the CC&Rs and ask for waiver; i.e. construction trailer in
 drive for short period; visiting guest with motorhome or boat, etc.
- Home owners Chuck and Nicole Zamary offered to print documents for the board, in an attempt to save HOA money.
- Paige Warren indicated she had purchased optical eyes for the front landscaping lights, but did not feel
 comfortable installing them, it was then stated if any home owner has special skills that may safe HOA
 money provide email to board.
- Lisa Miller asked if anyone in attendance would like to be nominated for the new HOA board of directors, even though we couldn't vote, it would be nice to know a little something about the people that showed an interest, in advance of the next meeting.
- The following people stated they would like to be considered for the next HOA Board of directors:

- Chuck Zamary (Determination Ct); Joseph Valentino (Perception Cr); Diane Aldridge (Integrity Ct)
- Current board members Paige Warren and Joey Milstead expressed interest in remaining on the board
- Karen Rothwell wanted to make sure all residents knew there is a New K-8 School planned for construction at the north east end of Whisper Creek Blvd. This school project is currently advertising using Whisper Creek Blvd as the primary access/entrance to the new school. There is a 24.5-acre parcel that was donated to the county, that is the planned location for new school. Several homeowners attended recent Board of County Commissioners meeting and expressed opposition to this planned use of our roads. Karen and Paige Warren suggested creating a group of concerned citizens to oppose this use of our road, and attend all scheduled Zoning Board, School Board and County Commissioners meeting in the future. Home Owners need to stand together and be heard if there is any hope of opposing this road use. This group will provide other viable options but need a force of voters to make the case. They will advise via Facebook of upcoming meetings etc.
- Keven Maxwell made a motion to adjourn this meeting and was 2nd by Marc Smith.
